FP7 Key facts and figures

Applications:

As of 2013/10/25, a total of

- 611 eligible proposals were submitted in response to 467 FP7 calls for proposals
- involving 681 applicants from MECKLENBURG-VORPOMMERN (0,97% of DE and 0,14% of EU-28*)
- requesting EUR 203,41m of EC contribution (0,71% of DE and 0,11% of EU-28*)

Among the NUTS1 regions of Germany (DE), MECKLENBURG-VORPOMMERN ranks:

- 16th in terms of number of applicants and
- 16th in terms of requested EC contribution

Among the NUTS1 regions of EU-28*, MECKLENBURG-VORPOMMERN ranks:

- 90th in terms of number of applicants and
- 85th in terms of requested EC contribution

Success rates:

- The MECKLENBURG-VORPOMMERN applicant success rate of 20,3% is lower than the DE applicant success rate of 24,3% and similar to the EU-28* applicant success rate of 20,9%.
- The MECKLENBURG-VORPOMMERN EC financial contribution success rate of 18,3% is lower than the DE rate of 23,7% and lower than the EU-28* rate of 19,7%.

Specifically, following evaluation and selection, a total of

- 127 proposals were retained for funding (20,8%)
- involving 138 (20,3%) successful applicants from MECKLENBURG-VORPOMMERN and
- requesting EUR 37,25m (18,3%) of EC financial contribution

Among the NUTS1 regions of Germany (DE), MECKLENBURG-VORPOMMERN ranks:

- 14th in terms of applicants success rate and
- 15th in terms of EC financial contribution success rate

Among the NUTS1 regions of EU-28*, MECKLENBURG-VORPOMMERN ranks:

- 61st in terms of applicants success rate and
- 53rd in terms of EC financial contribution success rate

Signed grant agreements

As of 2013/10/25, MECKLENBURG-VORPOMMERN participates in

- 136 signed grant agreements
- involving 2.137 participants of which 144 (6,74%) are from MECKLENBURG-VORPOMMERN
- benefiting from a total of EUR 651,58m of EC financial contribution of which EUR 47,21 m (7,25 %) is dedicated to participants from MECKLENBURG-VORPOMMERN.

Among the NUTS1 regions of Germany (DE), MECKLENBURG-VORPOMMERN ranks:

- 16th in number of participations and
- 15th in budget share

Among the NUTS1 regions of EU-28*, MECKLENBURG-VORPOMMERN (DE) ranks:

- 89th in number of participations and
- 81st in budget share

SME performance and participation

- The MECKLENBURG-VORPOMMERN SME applicant success rate of 18,78% is lower than the DE SME applicant success rate of 22,92% and it is lower than the EU-28* SME applicant success rate of 20,17%.
- The MECKLENBURG-VORPOMMERN SME EC financial contribution success rate of 19,66% is lower than the corresponding DE rate of 23,21% and it is similar to the corresponding EU-28* rate of 20,08%.

Specifically,

- 213 MECKLENBURG-VORPOMMERN SME applicants requesting EUR 56,42m
- 40 (18,78%) successful SMEs requesting EUR 11,09m (19,66%)

In signed grant agreements, as of 2013/10/25,

- 31 MECKLENBURG-VORPOMMERN SME grant holders, i.e., 21,53% of total MECKLENBURG-VORPOMMERN participation
- EUR 6,72m, i.e., 14,23% of total MECKLENBURG-VORPOMMERN budget share

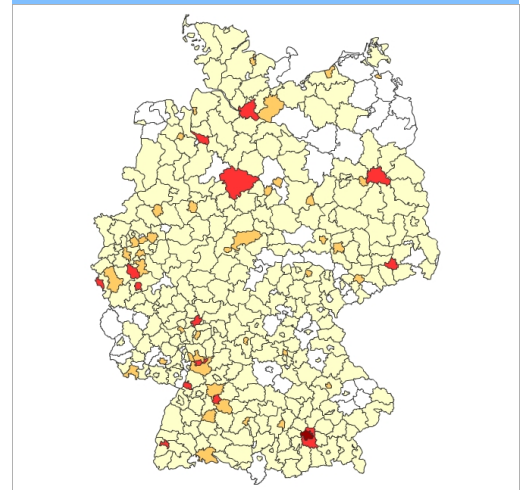

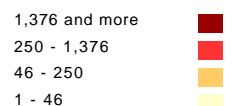
